## March Advocacy Call Recap

### **Quick Hill and Administration Update**

**Senate:** Chairman Marco Rubio (R-FL) and Ranking Member Ben Cardin (D-MD) of the Senate Committee on Small Business and Entrepreneurship, sent a [letter](#) to Administrator Jovita Carranza, requesting information on the agency's plan to ensure small businesses are prepared to respond to potential disruptions caused by the worldwide spread of the coronavirus. The Senate SB and Entrepreneurship Committee will hold a hearing titled, "The Coronavirus and America's Small Business Supply Chain" at 10:00 AM ET on March 12, 2020. **House:** Chairwoman Nydia Velázquez (D-NY) of the House Small Business Committee released a [statement](#) on the passing of [H.R. 6074](#), the Coronavirus Preparedness and Response Supplemental Appropriations Act, which included a provision based on legislation recently introduced by Reps. Nydia M. Velázquez (D-NY), Judy Chu (D-CA) and Grace Meng (D-NY) that would enable the Small Business Administration to make an estimated \$7 billion in low-cost loans to affected small businesses. The House SBC will hold a hearing titled, "The Impact of Coronavirus on America's Small Businesses" on Tuesday, March 10<sup>th</sup> at 11:30 AM ET. **Administration:** On Friday, March 6<sup>th</sup>, President Trump signed the [\\$8.3 billion supplemental spending bill](#) to combat the spread of the Coronavirus. This include The United Kingdom published its negotiating [objectives](#) for a U.S. trade deal, clearing the way for talks to formally start this month. In other news, the Small Business Administration (SBA) released a [notice of changes and request for comments](#) on the Community Advantage program, a program to increase SBA-guaranteed loans to small businesses in underserved areas. The changes will remain in effect until September 30<sup>th</sup>, 2022. The request for comment deadline on the changes is set for April 1<sup>st</sup>, 2020. Just one more item of interest, a new WBC is headed to West Virginia!

## **New Legislation Update**

### ***Endorsed by NAWBO***

On Thursday, March 5<sup>th</sup>, U.S. Senators Tammy Duckworth (D-IL), Tim Scott (R-SC), Ben Cardin (D-MD) and Susan Collins (R-ME) introduced [S.3406](#), the Interagency Committee on Women's Business Enterprise Act of 2020, a bill to reauthorize a federal interagency committee that helps coordinate federal resources to encourage the formation, growth and success of women-owned businesses. NAWBO endorsed this legislation.

On Tuesday, March 10<sup>th</sup>, NAWBO [announced](#) its support of Rep. Andy Kim (D- NJ) and Rep. Tim Burchett (R- TN) Bipartisan "Microloan, Major Impact" Package. It includes [H.R.6078](#) and [H.R.6079](#). These bills strive to increase the size of, and ease of obtaining, Microloans through the Small Business Administration (SBA). ## **Addressing the Workforce**

### **Senate**

- Senator Martin Heinrich (D-NM) introduced [S.3376](#) a bill to amend title XX of the Social Security Act to provide low-income individuals with opportunities to enter and follow a career pathway in the health professions, to extend and expand demonstration projects, and for other purposes.
- Senator Tim Kaine (D-VA) introduced [S.Res.515](#) a resolution supporting the goals and ideals of Career and Technical Education Month as well as [S.3273](#) a bill to amend the Higher Education Act of 1965 to establish a community college and career training grant program.
- Representative James Langevin (D-RI-2) introduced [H.R.6032](#) a bill to direct the Secretary of Transportation to designate certain consortia as Community and Technical College Centers of Excellence in Transportation Workforce Training, and for other purposes.
- Senator Masto Cortez (D-NV) introduced [S.3245](#) a bill to advance STEM education, provide for improved worker training, retention, and advancement, and for other purposes.
- Senator John Thune (R-SD) introduced [S.3355](#) a bill to address the workforce needs of the telecommunications industry.

### **House**

Representative Tom O'Halleran (D-AZ-1) introduced [H.R.5835](#) a bill to amend the Fair Labor Standards Act of 1938 to exempt certain employees engaged in outdoor recreational outfitting or guiding services from minimum wage and maximum hours requirements.

## **Medical Leave**

Sen. Elizabeth Warren (D-MA) and Rep. Janice Schakowsky (D-IL) introduced [S.3358](#) and [H.R.5991](#), identical bills that extend protections to part-time workers in the areas of family and medical leave and pension plans, and to ensure equitable treatment in the workplace.

### **Request for Input: [S. 1978 Corporate Transparency Act](#)**

Sen. Rubio's Small Business Committee Staff is looking for input on Corporate Transparency Act

- This bill requires certain new and existing small corporations and limited liability companies to disclose information about their beneficial owners.
- If they meet the standards, they must file beneficial ownership information with the Financial Crimes Enforcement Network (FinCEN).
- The bill imposes a civil penalty and authorizes criminal penalties—a fine, a prison term for up to three years, or both—for providing false or fraudulent beneficial ownership information or for willfully failing to provide complete or updated beneficial ownership information.
